

**TAXPAYER'S RSA 72:34-a**  
**EXEMPTION, DEFERRAL OR TAX CREDIT APPEAL**  
**TO THE BOARD OF TAX AND LAND APPEALS**

**INSTRUCTIONS**

1. There are distinct statutory requirements for different exemptions. Thus, Taxpayers should review RSA ch. 72 and comply with all applicable requirements.
2. Complete the appeal document by typing or legibly printing.
3. File this appeal document with the board of tax and land appeals (BTLA) within the RSA 72:34-a deadlines (See below).

**Deadlines:** "Date of notice of tax" means the date the board of tax and land appeals determines to be the last mailing date of the final tax bill for which relief is sought. If your municipality bills twice annually, you must appeal after the bill that establishes your final tax liability and not before.

**Step One:** Taxpayer must comply with all applicable RSA ch. 72 requirements.

**Step Two:** Taxpayer must file an appeal to the BTLA or superior court no later than September 1, following notice of tax, even if the municipality has not responded to the Taxpayer's RSA 72:23-c annual list or RSA 72:33 application.

4. **SECTIONS A & B.** Until otherwise informed in writing by the person(s) appealing, all orders, notices and communications shall be made to: a) the person(s)' listed address and phone number; or b) the representative's address and phone number.
5. **SECTION C.** List only the properties you are appealing and for which an exemption, deferral or tax credit application was filed with your municipality. A person(s) may use the same document to appeal more than one property, provided the properties are all in common ownership.
6. **SECTION F.** Attach a copy of the RSA 72:23-c annual list or the RSA 72:33 exemption, deferral or tax credit application filed with the municipality.
7. Make a copy of the appeal document for your file.

**NOTE:** Filing this document only appeals the exemption, deferral or tax credit issues; it does not appeal any other valuation assessment issues. If you also wish to appeal the assessment, you must separately appeal under RSA 76:16 and RSA 76:16-a.
